Does EPA fund solar for all projects?

EPA will not fund individual projectsthrough Solar for All. A Solar for All program is a program that ensures low-income households have access to residential rooftop and residential-serving community solar energy, often through providing financial support and other incentives.

Does Massachusetts have a solar photovoltaic program?

As Massachusetts has a strong existing solar photovoltaic industry, the initiatives offered under the SFA Program are designed to leverage federal funding and existing Massachusetts programs, such as the Solar Massachusetts Renewable Target program and Mass Save.

What enabling upgrades are eligible for solar for all financial assistance?

Applicants may decide the exact types of enabling upgrades that are eligible for Solar for All financial assistance, yet all enabling upgrades should be energy and building infrastructurerelated and deployed in conjunction with financial assistance for an eligible solar PV system.

Can EPA remove a coalition member from solar for all?

Yes, applicants may apply to Solar for All with a different list of coalition members than was originally listed in the Notice of Intent, including removing a coalition member. Can EPA provide contact information for entities that submitted NOIs?

Is solar photovoltaic the least expensive electricity option?

While solar photovoltaic (PV) is already the least expensive electricity option in dozens of states, it is important to bring this low-cost, zero-carbon electricity to more parts of the country to save American families money.

Who is eligible for solar for all?

States,territories,Tribal governments,municipalities,and eligible nonprofit recipientsare eligible to apply for Solar for All. These categories include: States &Territories: All 50 states,the District of Columbia,the Commonwealth of Puerto Rico,the Virgin Islands,Guam,American Samoa,and the Commonwealth of the Northern Mariana Islands.
