### Are solar panels illegal?

Certain homeowners associations (HOAs) prohibit solar panel installations, but these are generally illegal and unenforceable. Generally, you may assume that solar panel installations are acceptable, even encouraged by the government. However, it does not mean solar panel installations do not cause issues between businesses and homeowners.

#### Can HOAs ban solar panels?

In short,HOAs cannotban installations of any solar energy device. Still,they may regulate it on aspects such as approving only certain types of solar energy devices,providing maintenance,and requiring homeowners to apply for approval before installing solar panels.

Do solar PV installations need local government approval?

All solar PV installations need the local utility's approvalto link into the electricity grid, a process commonly referred to as "interconnection." This interconnection approval must be granted before a solar PV installation is allowed to operate and is completely separate from local government approval for the solar installation.

Can a rooftop solar PV system be installed on a building?

The vast majority of rooftop solar PV systems are installed on existing structures. Even though very few of these buildings were constructed specifically for installing solar equipment, many of them are well suited for PV systems.

### What if a roof is not covered by solar PV panels?

Roof surfaces not covered by solar PV panels shall be designed for the roof live load(CBC Section 1607). The building official may determine that live load need not be considered for solar PV panels and associated supporting members that are built on grade.

### How does the solar law affect the sale of solar panels?

The Legislative effort to "protect solar customers" has complicated the sale of these solar devices in many ways. Part of the law now requires the seller to specify the lifetime maintenance costs of systems,yet the law offers no definition of the lifetime nor is there any technical consensus on the issue.
