#### Can I import solar cells from Cambodia?

Imports of solar cells and modules from Cambodia, Malaysia, Thailand, and Vietnam will not be subject to suspension of liquidation or cash deposit requirements if accompanied by a certification attesting that they are not circumventing the ADD/CVD orders. There are three types of certifications:

#### Why is China Shipping solar products through Cambodia?

Commerce found that certain Chinese producers are shipping their solar products through Cambodia, Malaysia, Thailand, and/or Vietnam for minor processing in an attempt to avoid paying antidumping and countervailing duties (AD/CVD).
