Do solar panels qualify for tax credit?

After installing solar panels, you can claim the tax credit on the IRS filing that corresponds to the year you installed your system. For example, a solar installation completed in June 2024 would generate a federal tax credit that the owner could claim in April 2025. Who Qualifies for the Federal Solar Tax Credit?

Can I claim a tax credit if I install a solar PV system?

Yes, but if the residence where you install a solar PV system serves multiple purposes (e.g., you have a home office or your business is located in the same building), claiming the tax credit can be more complicated.

How do solar PV tax credits work?

For example, if your solar PV system was installed in 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows: State tax credits for installing solar PV generally do not reduce federal tax credits--and vice versa.

Are solar panels tax deductible?
