How does trade protection affect China's photovoltaic industry?

The export expansion of Chinese photovoltaic industry under trade protection The trade pattern of Chinese PV exports is largely reshaped by the trade sanctions. Both local and destination spillovers are conducive for the market re-organization of Chinese PV firms.

### Does trade protection affect global PV trade patterns?

The global PV trade patterns Empirical studies predict that a shock that hits anywhere would be transmitted throughout the trade network (Prusa,1997). Accordingly, the impact of trade protection on Chinese PV export will inevitably transmit to global PV trade patterns.

#### How much do PV firms export to China?

Such a figure occupies about 8.36% of other countries' export to China. The trade diversion is about 6669 million dollars, occupying about 22.71% of the PV export from ROW to AD countries. 3.4. How much of China's PV exports deflect to new markets?

The results show that about 20 billion dollars of PV products, account for 22.66% of China's overall PV export, deflected to new markets from 2012 to 2016. Both local and destination spillovers are conducive for Chinese PV exports to deflect to countries without extra tariffs.

Do Green trade barriers affect photovoltaic exports?

Specifically, green trade barriers have a positive impacton the export of photovoltaic products in countries with higher exchange rates and different official languages, whereas their impact is insignificant or negative in countries with lower exchange rates and the same official language.

## How does trade deflection affect China's PV market?

Thus,firms in China are urged to find new markets. As a result,China's PV export to the ROW might increase(trade deflection) while China's PV import from the ROW will decrease (trade depression). The effects of trade destruction and trade diversion have been widely confirmed (Durling and Prusa,2006; Park,2009).
