How long can you go to prison for stealing money?

If law enforcement convicts you of stealing between \$2,000 and \$5,000, you may only serve as long as one and a half yearsin prison. But if the dollar amount exceeds \$100,000, the prison sentence can rise past ten years. Here is a look at how the felony levels correspond to prison sentencing:

How long do federal charges last?

Federal charges can lead to 10 yearsor more in federal prison. When deciding the appropriate sentence, judges will generally look at the nature of the current offense (amount of harm done, targeting of any vulnerable victims), the defendant's criminal records, and the public safety interests involved.

What are the penalties for stealing a property?

Each state has its own penalty scheme that often depends on the value or type of property embezzled and whether aggravating factors were involved (such as stealing from an elderly adult). Misdemeanor or felony. Generally, the greater the loss is, the higher the penalty will be.

What happens if a person steals money from the US government?

Public money, property or records: Anyone who embezzles money, records, property or any other item of value to the US government that is worth more than \$1000 will get a fine of \$250,000, up to 10 years in prison or both. If the value is under \$1000, the fine can be up to \$100,000 and up to a year in jail, or both.

What happens if a government employee steals building materials?

If that employee steals building materials that the government paid for, then he could be charged with federal embezzlement. Federal embezzlement laws differ somewhat from state laws. State laws cover thefts by public officials who work for state and local governments, but also embezzlement by people who do not work for the government.

How long can a judge aggregate a stolen property?

Some states allow the judge to aggregate the value over a specific time period (such as 12 months), while other states do not impose any time period--for example, when the embezzlement involved only one victim. In these states, the defendant will be charged and sentenced depending on the total worth of the money or property stolen.
