

How to apply quota for solar power generation

When will the Solaris rebate quotas be distributed?

*Subject to the terms and conditions of the SolaRIS programme. Rebate allocation is on a first come, first served basis from 1 April until 31 December 2024 and successfully commission their solar PV system installations by 31 March 2025, or until all SolaRIS rebate quotas are fully distributed, whichever comes first.

What is e-bidding & fit quota application?

SEDA Malaysia introduced FiT quota application via e-Bidding on the e-FiT system platform in an effort to spur the renewable energy capacity and generation growth. It all began in 2018 with a focus on biogas quota and the idea quickly expanded to include small hydropower quota was added in 2019.

Can I apply NEM quota directly from SEDA?

You can apply NEM quota directly from SEDA. If you join any of TNB solar solution, we will take care that for you. Can I reduce electricity cost by going solar? Yes. Typical saving is between 10-15% depending on your PV size, financing option, actual solar energy production and system performance.

How do I update RE quota?

The e-FiT system has been enhanced with a more user-friendly portal; displaying automatic real-time update of RE Quota on a separate RE Quota webpage. Please click the button to get the latest update of RE Quota available for any Feed-in Approval application.

What if solar energy is not fully used?

If the energy generated is not fully used, you can supply the excess to TNB grid. When solar energy is insufficient or at night when there is no access to sunlight, TNB will supply the energy to you. By generating your own electricity, you will use less energy from TNB. Therefore, this will help to lower your electricity bill.

Is a feed-in tariff a quota?

No, it is not. FiT or Feed-in Tariff is a mechanism for granted selected customers to export all solar energy produced to TNB grid and the quota has long been fulfilled for solar. The main difference is NEM mechanism allows you to generate your own energy and use it to reduce electricity bill.
