Massachusetts law Chapter 40A states that "no zoning ordinanceor by-law shall prohibit or unreasonably regulate the installation of solar energy systems or the building of structures that facilitate the collection of solar energy, except where necessary to protect the public health, safety or welfare."

### Can a county restrict a solar energy system?

ems 66.0401(1) (1) Authority to restrict systems limited. No county, city, town, or village may place any restriction, either directly or in effect, on the installation or use of a solar energy system, as defined in s. 13.48 (2) (h) serve or protect the public health or safety. 66.0401(1)(b)Does not significantly increase th

What happens if a solar project is not regulated?

Failing to make regulatory distinctions between sizes or types of solar development projects may allow utility-scale projects to be approved at the same regulatory and permitting cost as much smaller arrays or to be sited on prime farmland without evaluating impacts to agriculture.

#### Do state and local laws regulate solar arrays?

State and local laws primarily regulate decisions about how and where we build electricity infrastructure, including new solar arrays. While the federal government is involved in the siting of natural gas, hydroelectric plants, and certain transmission infrastructure, it has no authority whatsoever over the siting of solar arrays on private land.
