

# Is it illegal to install photovoltaic panels now

Is installing solar panels illegal in any state?

Technically, no state outlaws or bans solar panels; quite the opposite. Most states have solar access laws that forbid any agreement, covenant, condition, by law, or contract that outlaws or limits solar installations by Homeowners Associations (HOA) or other municipal bodies.

### Are HOAs allowed to install solar panels?

For example, in 2022, the North Carolina Supreme Court and the Indiana legislature limited HOAs' power over solar panel installations. But not all stateshave laws that guarantee HOA residents the right to install solar panels, leaving homeowners there without much legal leverage. What are solar access laws?

#### Are solar access laws illegal?

With that being said, unpermitted systems are illegal to operate in many American jurisdictions, even in states with solar access laws. What is the difference between solar access laws and solar easement laws?

### Will new solar rules discourage people from installing solar panels?

And solar developers say the rules will discourage people from installing solar panels. A victory for the solar industry came earlier this year, when the commission dropped an unpopular plan to charge homeowners an 8% per kilowatt-hour tax for new solar systems.

Do solar access laws guarantee the right to solar power?

Mendelsohn notes that solar access laws may not alwaysguarantee the right to solar power. He says he's encountered HOAs that previously restricted solar installation in building codes and those clauses have been grandfathered in, even after solar access laws were passed by their states.

### Are solar panels a viable option?

However, some states still make installing solar panels functionally impossible by creating laws with "reasonable restrictions," such as increased taxing, energy caps, or even billing solar panel users. Combine these laws with a lack of incentive programs, and solar panels are not viable for homeowners in many states.
