# Are solar panels tax deductible?

Under most circumstances, subsidies provided by your utility to you to install a solar PV system are excluded from income taxes through an exemption in federal law. When this is the case, the utility rebate for installing solar is subtracted from your system costs before you calculate your tax credit.

#### How do solar PV tax credits work?

For example, if your solar PV system was installed in 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows: State tax credits for installing solar PV generally do not reduce federal tax credits--and vice versa.

#### Is the solar tax credit refundable?

The federal solar tax credit is nonrefundable, meaning you can't reduce your tax liability lower than zero and receive a refund for the credit from the IRS. You can, however, carry forward any remaining balance to offset your taxable income in future years until the credit is fully recouped.

## How much is a residential solar energy credit worth?

The residential solar energy credit is worth 30% of the installed system costs through 2032. 26% in 2033. 22% in 2034 and expires after that. What is the Residential Clean Energy Credit? In an effort to encourage Americans to use solar power, the US government offers tax credits for solar systems.

### How does a solar PV rebate work?

For example, if your solar PV system was installed in 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows: \$18,000 \* 0.30 = \$5,400

### What is the Federal residential solar energy credit?

The federal residential solar energy credit is a tax credit that can be claimed on federal income taxes for a percentage of the cost of a solar PV system paid for by the taxpayer. (Other types of renewable energy are also eligible for similar credits but are beyond the scope of this guidance.)
