Do Americans get free solar panels?

American homeowners might be eligible for federal tax credits for solar installations or state subsidies for solar energy, but not free panels. The U.S. government does not provide free solar panels, said a U.S. Department of Energy spokesperson. The department urges people to report scams to the .

Does the federal government offer free solar panels?

The federal government does not provide free solar panels, but does provide incentives that reduce the cost of going solar. You can go solar with no upfront cost by taking out a \$0-down loan, signing a lease or PPA, or subscribing to a community solar farm. Of the no upfront cost solutions, \$0-down loans provide the best long-term savings.

Are free solar panels worth it?

"Free" solar panels will save you money because energy from solar power is usually less expensive than energy from the electrical grid. Keep in mind, however, that these savings from solar energy are possible regardless of if your solar panels are leased versus purchased.
