Are BP Solar panels eligible for a class action settlement?

If you have BP solar panels you may be entitled to replacement of the solar panels and/or a new inverter from a class action settlement. Important Updates: A new model number, BP365TS, has been added to the list of eligible Class Panels. Please see the Long Form Notice for further details.

Who sued vision solar?

Vision Solar was also sued by Connecticut Attorney General William Tongin March after the office received more than a dozen consumer complaints. Can I sue a solar company for misrepresentation?

Who is involved in a SunPower lawsuit?
