Who participates in the financing of solar projects?

Developers, independent power producers, solar panel manufacturers, engineering, procurement, and construction ("EPC") contractors, utility companies, financial investors and, more recently, commercial and industrial end-users all participate in the financing of solar projects in different manners and at different times.

What is a solar power purchase agreement (SPPA)?

A Solar Power Purchase Agreement (SPPA) is a financial arrangement which a third-party developer owns, operates, and maintains the photovoltaic (PV) system, and a host customer agrees to site the system on its property and purchases the system's electric output from the solar services provider for a predetermined period.

Can a solar project get financing?

What is a solar service provider (SPPA)?
