What is the future of energy storage?

Will energy storage grow in 2024?

What is the growth rate of industrial energy storage?

Can stationary energy storage improve grid reliability?

Although once considered the missing link for high levels of grid-tied renewable electricity, stationary energy storage is no longer seen as a barrier, but rather a real opportunity to identify the most cost-effective technologies for increasing grid reliability, resilience, and demand management.
