The Installation Agreement is a lump-sum agreement between the project company, as owner of the project, and the installation contractor, the contractor that will be responsible for installing the PV system, providing the balance of plant and commissioning the plant.

Can a provider sell a photovoltaic system to a customer?

WHEREAS, Provider has offered, at his sole cost and expense, to install, maintain, own, replace, repair, and operate a photovoltaic system at one or more of the Property (ies) and to sell Solar Services (as hereafter defined) produced by the solar photovoltaic system to Customer as provided in and subject to the provisions of this Agreement.

What are the requirements for a photovoltaic module?

According to the agreement, proposed photovoltaic modules must be in compliance with the following requirements: (i) Monocrystalline or Polycrystalline, (ii) eligible under the California Solar Initiative ("CSI") Program, (iii) in compliance with IEEE standards, including without limitation, IEEE 1262, and (iv) UL listed, and (v) in compliance with the current National Electrical Code.
