Who owns WeChat Pay & Alipay?

By Cameron Caldwell (University of Glasgow) and Jennifer Liu (McGill University) Two of China's 'Big Tech' players, Tencent and Alibaba, owners of WeChat Pay and Alipay respectively, have revolutionised the payment industry in China with the introduction of an alternative payment ecosystem.

What are Chinese payment platforms - WeChat & Alipay?

Chinese organisations, namely WeChat and Alipay, were pioneers in new payment technology that uses QR codes and in-app features to pay for goods and services. As the organisations that own WeChat and Alipay grow, so too these platforms now dominate the Chinese payment industry, with large usage nationally.

Is WeChat Pay better than Alipay?

WeChat Pay may be better if the majority of your income is earned and spent in China, and you are looking for an online payment system that integrates into China's most popular social media platform. But if global convenience for financial services is a priority for you, consider Alipay.

Is Chinese digital currency a competitor to WeChat Pay & Alipay?

Although the digital currency is not expected to widely circulate in the next few years, this test sent a signal that Chinese digital currency is a potential competitor to WeChat Pay and Alipay, which currently processes about 95% of digital payments in China.

Does Alibaba accept WeChat Pay?

Brands and businesses can set it up to sell products directly within the platform while using WeChat Pay as the payment method. Although WeChat Pay is unavailable in Alibaba-related e-commerce mobile apps, it's an acceptable payment platform on JD.com, Pinduoduo, and Little Red Book. How many people use WeChat & Alipay in China?

Alipay reached 1.2 billion monthly users in 2019⁶ and WeChat Pay surpassed one billion users in 2018.⁷ These two forms of payment dominate the Chinese market. Over 90% of people in China's largest cities use WeChat Pay and Alipay as their primary payment method, with cash second, and card-based debit/credit a distant third.⁸
