Can Agricultural Producers apply for new energy efficient equipment & system loans?

Agricultural producers may also apply for new energy efficient equipment and new system loans for agricultural production and processing. Who may apply for this program? Agricultural producers with at least 50 percent of their gross income coming from agricultural operations.

Can a solar energy project be funded by USDA?

Can the USDA REAP grant be combined with other solar incentives?

Yes. The USDA REAP Grant may be combined with local, state, and federal solar incentives and energy tax credits. As mentioned above, you may be asked to provide a funding commitment statement from any other sources of funding therefore prearrange other solar incentives if possible.

What is an electric program Project Financing Loan?

Electric Program project financing loans follow the same regulatory requirements and processes as do our traditional electric infrastructure loans and loan guarantees (also known as system loans or loans for rural electrification).

Can a rural business use SBA-guaranteed capital for a REAP grant?

Rural businesses and agricultural producers may consider leveraging SBA-guaranteed capital to meet the REAP grant program's 50% cost share requirement, or to meet the remainder of any project costs. Visit SBA's Lender Match tool to find lenders that may be interested in funding your business.
