### Are people deceived by solar financing companies?

We don't want people deceived, though," says Adam Welle, a lawyer with the Minnesota Attorney General's Office who is pursuing a case against solar financing companies. Beyond the industry's reputation, real people - many of them already financially vulnerable - have been hurt.

#### Are solar panels a scam?

Here's how to steer clear of the scams: Do some research. Avoid solar companies that say a government program will cover the whole cost of solar panels -- or say they're from (or affiliated with) the government. These are lies. If you're looking at solar energy for your home, get quotes from reputable providers with a valid license.

#### Was DC Solar a scam?

It was the largest criminal fraud schemein the history of the district, which includes Sacramento and Fresno. According to prosecutors, from 2011 to 2018, DC Solar manufactured mobile solar generator units and, because they used solar energy, buyers could obtain federal tax credits. The reality was much different, authorities say.

# Why is Minnesota suing a solar loan company?

Minnesota is suing firms who finance solar power systems for homes. The case alleges that four lending companies deceived customers with hidden, upfront fees in exchange for lower interest rates. "It's misleading people about the price of the system and misleading people about the price of financing," says Assistant Attorney General Welle.
