Do solar projects need an EPC contract?

In our experience,most utility-scale solar projects use an EPC Contract. An operation and maintenance agreement: This is usually a medium- to long-term Operating and Maintenance Agreement (O&M Agreement) with an Operator. The term of the O&M Agreement will vary from project to project.

Do you need a solar power agreement?

These agreements can be related to a solar power lease,PPA,or outright buying of the system. Whenever developing alternate forms of power,it's good to have an agreement with your Provider. This ensures everyone is clear on their roles and responsibilities.

What should a solar installation contract include?

Your solar installation contract should include crucial details about what happens and who is responsible for each, such as: Before your solar panel installation company can begin work on your roof, they have to get construction and/or electrical work permits from the city or county where you live.

How does a solar energy contract work?

Homeowners who pay for their panels upfront with cash, or through a solar loan, will see something different than someone who signs a solar lease or solar power purchase agreement (PPA).
