Are Chinese solar companies coping with a trade dispute?

Chinese solar companies are capable of mitigating riskswhile maintaining their competitive edge in the international market amid an ongoing trade dispute, as they have been stepping up efforts to diversify their global operations in recent years, experts and business insiders said.

Will European solar panels be able to trade with China?

European solar panel manufacturers have previously asked the EU to consider trade safeguards on Chinese imports, but Brussels and governments including Germany have warned broad curbs on Chinese supply could stunt Europe's fast expansion of clean energy.

What are the trade policies regarding solar panel imports?

The archive below summarizes the development of trade policies concerning solar panel imports: Antidumping and Countervailing Duties(AD/CVD) Order imposed additional duties on Chinese solar cells. Additional duties were placed on solar modules assembled in China and solar cells from Taiwan.

Are solar panel import tariffs affecting the US solar industry?

As the United States reevaluates its declining manufacturing base in contrast to China's growing influence, solar panel import tariffs remain a significant factor in shaping the industry. Since 2012, the U.S. Commerce Department has subjected all solar modules containing certain key components from China to import tariffs.

Does Solarpower Europe support trade measures?

However, Solar Power Europe, an industry body that counts Chinese telecoms company Huawei among its members, has publicly campaigned against trade measures. "We have repeatedly warned that EU and national policymakers must rapidly act with real solutions," said Solar Power Europe chief executive Walburga Hemetsberger.

Why did the US impose a solar safeguard measure?

In early 2018, the United States imposed the solar safeguard measure to support the domestic solar industry's efforts to adjust to import competitionprimarily attributable to excess solar cell and module capacity by Chinese producers in China and around the world and exacerbated by China's non-market practices.
