

Tax exemption policy for solar power generation

Can I get a tax credit for solar energy?

There are two tax credits available for businesses and other entities like nonprofits and local and tribal governments that purchase solar energy systems (see the Homeowner's Guide to the Federal Tax Credit for Solar Photovoltaics for information for individuals):

What is a solar sales tax exemption?

The sales tax exemption also includes all components used in solar energy systems as well as sales and energy storage costs. This helps to reduce the cost of purchasing an entire solar system that would otherwise be applied to the final transaction.

Who is eligible for a solar PV tax credit?

A tenant-stockholderat a cooperative housing corporation and members of condominiums are still eligible for the tax credit if they contribute to the costs of an eligible solar PV system. In this case, the amount you spend contributing to the cost of the solar PV system would be the amount you would use to calculate your tax credit.

What is the Federal residential solar energy credit?

The federal residential solar energy credit is a tax credit that can be claimed on federal income taxes for a percentage of the cost of a solar PV system paid for by the taxpayer. (Other types of renewable energy are also eligible for similar credits but are beyond the scope of this guidance.)

Can I claim a tax credit if I install a solar PV system?

Yes,but if the residence where you install a solar PV system serves multiple purposes (e.g.,you have a home ofice or your business is located in the same building),claiming the tax credit can be more complicated.

When does the solar tax credit expire?

It will decrease to 26% for systems installed in 2033 and to 22% for systems installed in 2034. The tax credit expires starting in 2035unless Congress renews it. There is no maximum amount that can be claimed. Am I eligible to claim the federal solar tax credit? You might be eligible for this tax credit if you meet the following criteria:
