What is the tariff-rate quota for solar cells under Section 201?

Managing the tariff-rate quota for solar cells under Section 201 to support expanded solar manufacturing. Currently, there is a 5-gigawatttariff-rate quota for imported solar cells under Section 201.

What will the US government do if imported solar panels exceed quota?

The Administration will closely monitor the level of imported solar cells used to manufacture panels in the U.S. and will work to raise the quota by 7.5-gigawattsif imports approach the current quota level, to ensure domestic module manufacturing continues to grow while manufacturers scale production throughout the supply chain.

What does a new TRQ mean for solar?

The new measure, which increases the TRQ from 5 gigawatts (GW) to 12.5 GW annually, is aimed at supporting domestic solar manufacturers as they face increasing global competition. The change, set to take effect on August 1,2024, will allow for a higher volume of CSPV cell imports without triggering additional safeguard tariffs.

Are bifacial solar panels protected under Section 201?

Removal of the bifacial module exclusion under Section 201. Bifacial solar panels generally used in utility-scale solar projects are notcurrently subject to safeguard tariffs under Section 201 of the Trade Act of 1974.

Will bifacial solar panels be exempt from the safeguard measure?

The Proclamation also preserves the exemption of bifacial solar panels from the safeguard measure, and authorizes the US Trade Representative (USTR) to negotiate agreements with Canada and Mexico that could lead to the exclusion of those countries from the safeguard remedy.
