What happens if a solar panel is damaged?

Claims for damaged solar panels would also vary based on your insurance plan, but likely follows the same process as other damaged property claims. If you subscribe to a PPA or lease your solar panels, a third party owns your system and is responsible for damage and maintenance.

Are solar panels covered by a PPA?

If you subscribe to a PPA or lease your solar panels, a third party owns your system and is responsible for damage and maintenance. In this case, you will not be responsible for ensuring coverage, but you should talk to your lease or PPA provider before committing to make sure that any unforeseen damage will be covered.

Are solar panels covered under a homeowner's policy?

This means that as long as you own your solar panels and they are rooftop-mounted (additional policies may be required for ground-mounted systems), the system will be included under a homeowner's policy and covered in standard plans without raising your premium.

What happens if a solar panel is discarded?

Federal solid and hazardous waste regulations (i.e., the RCRA requirements) apply to solar panels when they are discarded. When a solar panel reaches the end of its usable life or is otherwise discarded, it becomes solid waste. Solid waste is regulated federally under RCRA Subtitle D and through state and local government programs.

How can solar power companies protect you from fraud?
